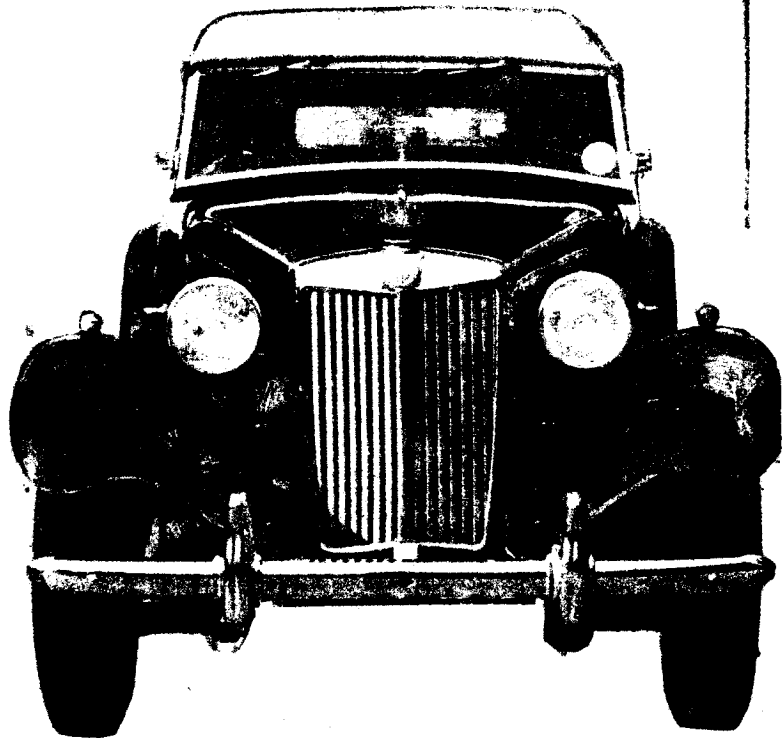

INAUGURAL MEETING. November 11th.

Over fifty motorists and their friends gathered at the Wooden Bridge Hotel, Guildford on the evening of Wednesday, November the 11th, when Mr. W.D.J. Roscoe took the chair at a meeting, out of which it was hoped the Guildford Motor Club would arise.

After the Chairman had welcomed those who had given their evening to attend the meeting, Mr. Arthur Knight explained what preparation had already gone into the formation of a Club and how it was proposed to bring it into existence.

The Chairman then threw the meeting open for questions, but from the few questions which were forthcoming it was apparent that the body of the hall endorsed Mr. Knight's proposals.

The election of Officers proved to be somewhat of a bone of contention because not all of those present agreed with the Chairman's idea of re-electing the provisional Committee "en bloc", the alternative being to vote that the Committee stand down and individual election of each member then take place. However, when this was put to the vote the meeting elected to retain its present Committee for a period of six months, but then only after Mr. A.H. Hague had requested that the competence of each member should be established.

The meeting closed after one hour and members adjourned to less formal pursuits in the bar.
